IMO STATE OF NIGERIA  
LAW NO. 15 OF 2021

A Law to appropriate the sum of N332,831,773,737 (Three Hundred and Thirty Two Billion, Eight Hundred and Thirty One Million, Seven Hundred and Seventy Three Thousand, Seven Hundred and Thirty Seven Naira) only to the services of the Government of Imo State of Nigeria for the year ending on 31<sup>st</sup> day of December, 2021 and for other related purposes. This excludes the Consolidated Revenue Fund Charges of **N13,338,198,348.00** (Thirteen Billion, Three Hundred and Thirty Eight Million, One Hundred and Ninety Eight Thousand, Three Hundred and Forty Eight Naira) only, hence a total Budget of **N346,169,972,085.00** (Three Hundred and Forty Six Billion, One Hundred and Sixty Nine Million, Nine Hundred and Seventy Two Thousand, Eighty Five Naira) only.

Long Title

**BE IT ENACTED** by the House of Assembly of Imo State of Nigeria as follows –

Enactment

1. This Law may be cited as the 2021 Imo State of Nigeria Appropriation Law and shall come into force on 1<sup>st</sup> January, 2021.
2. The Accountant-General may, when authorized to do so by Warrants signed by the Governor of Imo State of Nigeria, pay out of the Consolidated Revenue Fund of Imo State of Nigeria during the year ending 31<sup>st</sup> December, 2021 the sums specified by the Warrants not exceeding in the aggregate, **N61,306,043,593** (Sixty One Billion, Three Hundred and Six Million, Forty Three Thousand, Five Hundred and Ninety Three Naira) only.
3. The sums mentioned in Sections 2 and 3 shall be appropriated to the Heads of Expenditure as indicated in the First Schedule to this Law.

The Accountant-General may, when authorized to do so by Warrants signed by the Governor of Imo State of Nigeria, pay out of the Consolidated Revenue Fund of Imo State of Nigeria during the year ending on 31<sup>st</sup> December, 2021, the sums specified by the Warrants not exceeding in the aggregate **N61,436,309,407.00** (Sixty One Billion, Four Hundred and Thirty Six Million, Three Hundred and Nine Thousand, Four Hundred and Seven Naira) only.

The Accountant-General may, when authorized to do so by Warrants signed by the Governor of Imo State of Nigeria, pay out of the Capital Development Fund of Imo State of Nigeria, during the year ending on 31<sup>st</sup> of December, 2021 the sums specified by the Warrants not exceeding in the aggregate **N271,525,730,144.00** (Two Hundred and Seventy One Billion, Five Hundred and Twenty Five Million, Seven Hundred and Thirty Thousand, One Hundred and Forty Four Naira) only.

6. The sums mentioned in Sections 5 & 6 shall be appropriated to the Heads of Expenditure as indicated in the Second Schedule to this Law.




